2. REPORTS & PRESENTATIONS

2.1 Citizens Assembly

Julie Marsh provided an overview and thoughts on the recent public meeting concerning water in Denmark.

Rod Mitchell presented a paper for Councillors (attached) requesting Council consider a Citizens Assembly and the objectives of the group. In summary a Citizens' Assembly is a new way of involving citizen voters in public decision-making in policy areas extending beyond electoral reform. For others, it demonstrates the power of participatory democracy and the need to transform existing representative institutions.

2.2 Parry Beach Masterplan

Executive Manager of Community Services, Angela Simpson, provided an update on the Masterplan framework for Parry's Beach and associated timeframe.

2.3 McLean Oval Update

Manager of Recreation Services, Damian Schwarzbach, provided a report on the completion of McLean Oval including final expenditure measured against budget, project learnings, User Group feedback and satisfaction, maintenance and future plans.

2.4 Prawn Rock Channel (PRC)

The Director Assets & Sustainable Development, David King, discussed the recent service level failure at PRC and subsequent short term arrangements to address the failures, the 2015 Concept Plan and proposed next actions to resolve the issues.

2.5 Container Deposit Scheme

The Sustainable Development Officer, Bohdan Davies, presented information and updates on the Container Deposit Scheme including State service expectations in Denmark and the Shires role in delivery.

2.6 Salmon Canning

Mark Sheppard provided a brief update on the salmon season and operations. Mark answered questions on sustainability and future plans.

2.7 WALGA Zone Priority areas for consideration

Councillors were asked to consider key strategic priorities for the WALGA Zone's considerations. The Regional Economic Alliance will be forwarded to Councillors for future consideration, but the following areas of interest were identified:

- Water
- Transport
- Aged care
- Agriculture Horticulture and Value-adding
- Mobile abattoir
- Education (TAFE support)
- Tourism

2.8 Bushfire Read Program

Carl Wesley, Denmark Bushfire Ready Manager made a presentation on the Bushfire Ready Programs success in Denmark. The program is run exclusively by Volunteers and Carl asked Council to consider a small \$5,000 contribution next financial year to the program.

The Acting CEO, David Schober, provided the following documents:

The CEO then outlined four key priorities for Council and Executive staff from now until June 30:

Executive Manager of Corporate Services, Lee Sounness, provided an update and timeframe for the 2020/21 budget process. This included discussion on budget workshops with Councillors and consideration the current rate review process.
