2. REPORTS & PRESENTATIONS

2.1 Aquatic Feasibility Study Report and Update

Denmark Aquatic Centre Committee Inc. (DACCI) Chair, Dr Cyril Edwards, and Manager of Sustainable Projects, Damian Schwarzbach, jointly presented on the history of the Aquatic Centre research and findings of the recent feasibility study commissioned by the Shire and DACCI.

Recommendations

- 1. Update modelling once current Census data is released
- 2. Development of a Leisure Centre Masterplan, given the proposed Recreation Centre upgrades incorporated into the Long-Term Financial Plan.
- 3. Further investigation required re: lifecycle, hydraulics and staff costings

2.2 Rating review Stage 3 – Part 2

The Manager of Corporate Services presented an update in respect to the rating review on rural land holdings deriving an income not consistent with rural use. There are currently 18 properties in this category that could be split rated.

2.3 Ethical Investments – Part 1 – Background

The Director of Corporate and Community Services provided background, objectives and context to current investment strategies. Legislative requirements were presented along with requirements under the LG Act and associated risk management guidelines.

2.4 Denmark Mountain Bike Club

Alister Dickson, Club President and members, shared the clubs objectives and vision along with thoughts on the proposed Mt Hallowell trail.

2.5 Ethical Investments – Part 2 – Discussion

The Shire President and Director of Corporate and Community Services, led a discussion on the opportunities the Shire of Denmark may wish to pursue with respect to sustainable and ethical investments.

2.6 Elected Members Expense Policy

The Governance Coordinator led a discussion and answered questions on the attached draft Elected Members Expenses Policy.

Feedback received on ICT considerations and the need to amend the draft to reflect asset depreciation.

2.7 Corporate Business Plan – Part 1/4

The CEO and Corporate Planner provided the background, context and a proposed process for the consideration, and development, of the 2022/23 Corporate Business Plan. This will be in conjunction with the 2022/23 IPRF documents as well as the budget for the new financial year.

Councillors provided feedback on priority areas for consideration.

3. ALLIANCE UPDATE

The Shire President provided an update on Alliance business and the last two meetings with regard to activity for the 22/23 financial year.

CEO's are preparing an operational plan for the consideration of the May meeting.

Cr Lewis provided an update on the Climate Alliance activity, including the climate dashboard, waste reduction and transport opportunities. Shared the major role of the Alliance will be one of advocacy, rather than project delivery. Adaption of buildings and electrical vehicle analysis are the two projects being submitted for funding under the climate alliance program.
