1. HOW THE SPECIAL ELECTORS MEETING WILL BE CONDUCTED

- The Deputy Shire President will preside over the meeting. If the Deputy Shire President is unable to attend, the electors must choose a councillor present to preside. If there are no Councillors present, then the electors are to choose one of themselves to preside (s 5.30 of the Local Government Act 1995).
- The only matter to be discussed at this meeting is the matter detailed under Item 4 of this Agenda.
- All electors present are required to sign the Attendance Register with their name and address.
- Only electors are permitted to vote.
- Each elector* who is present is entitled to one vote on each matter to be decided at the meeting but does not have to vote.
- Voting is to be conducted so that no voter's vote is secret.
- All decisions are to be made by a simple majority of electors present.
- The presiding person will call for a mover and a seconder for any motions.
- If a motion is moved and seconded, it becomes live and the presiding person will facilitate debate.
- Debate will be limited to 3 speakers for the motion, and 3 speakers against the motion.
- Speakers for, or against, the motion will be limited to 3 minutes each.
- All decisions made at the meeting are to be considered at the next Ordinary Council meeting or, if that is not practicable, at the first Ordinary Council meeting after that meeting; or at a Special Meeting called for that purpose, whichever happens first.
- There will be no public question time, in accordance with Regulation 5 of the Local Government (Administration) Regulations 1996.
- The meeting procedure to be followed, other than those listed above, is to be determined by the person presiding.

* An **elector** means a person who is eligible to be enrolled to vote at Shire of Denmark local government elections.

4. PURPOSE OF THE MEETING

A request signed by more than 100 different Electors was submitted to the Shire President on 15 February 2022 requesting a Special Meeting of Electors for the following purpose.

The purpose of the Special Meeting is:

1. Discuss the Denmark community being declared a Pro Choice community in relation to the State Government vaccination mandates.
2. To hear and discuss community concerns in relation to the vaccination mandates.
3. Request that a vote be taken to oppose vaccination mandates and declare Denmark a Pro Choice community.
4. Request that the Shire President advise the Premier and State Parliament;
 - a) of community concerns in relation to existing mandates; and
 - b) request that they refrain from imposing further mandates as well as removing all existing mandates currently in place.

SPEAKERS

The Presiding Person had agreed to allow 3 persons to speak on behalf of the electors who requested the meeting. Cr Gibson advised that each speaker would be allocated 3 minutes.

1. Jessica Heller-Bhatt

Jessica said she was a Psychologist and that, due to the vaccine mandate, she had been dismissed from her role with the Department of Communities, Child Protection and Family Support. Jessica talked about the effects of discrimination including the division and segregation within communities.

Jessica suggested that people should not be deprived of their dignity including the right to make a living and their inherent right to political expression.

2. Dr Mitch Lever

Dr Lever advised that he had a background in microbiology and medical statistics and wished to highlight three facts which made it clear that the vaccine mandates were all risk, and no benefit.

Dr Lever referred to the statistics in numerous studies that demonstrated how the COVID-19 injections were causing harm. Dr Lever said that while the vaccination rate in WA had gone up, so had the number of case numbers, and that this was evidence that the vaccinations were ineffective. Dr Lever added that there was no evidence that asymptomatic people could infect other people.

3. Dr Mitch Sambell

Dr Sambell advised that he had previously worked as a medical Doctor, but had chosen to take on alternative employment because he had refused to have the vaccination. Dr Sambell said that everyone was expected to trust the science however, he had witnessed numerous cases of vaccine injury including, cognitive decline, stroke, heart attacks and blood clots.

Dr Sambell provided a number of statistics relating to the average number of deaths from the COVID vaccination, compared to the number of deaths from all other vaccinations in previous years. Dr Sambell noted that vaccinated people could still acquire and spread the disease and, asserted that people were being coerced into receiving a medical intervention, thereby removing their ability to consent.

MOTIONS

The following motions have been provided by the person who arranged the meeting request on behalf of the electors who signed the request.

Glossary of Terms and Definitions.

Access means to enter, or remain at a premises.

Approved COVID-19 vaccine means:

- a. any vaccine that has been approved by the Therapeutic Goods Administration (TGA) for use in Australia for the purpose of vaccinating persons against COVID-19 or any mutations and derivatives thereof; and/or,
- b. any other vaccine specified by the Chief Health Officer, or any other person authorised by the Chief Health Officer for that purpose, as an approved COVID-19 vaccine.

Premises has the same meaning that it has in the Public Health Act 2016 (WA).

Vaccine does not mean the medical terminology as defined in medical journals, but is the generic term in the context of COVID-19 as referred to by the Therapeutic Goods Administration and the Chief Health Officer and Government Officials, and publications and statements made and issued under their auspices.

Vaccination status means whether a person is not vaccinated or has been vaccinated.

Not vaccinated means that the person has not been administered with any dose of an approved COVID-19 vaccine.

Vaccinated means that the person has been administered with any prescribed doses of an approved COVID-19 vaccine.

4.1 COVID-19 VACCINATION PRO-CHOICE STATEMENT – PART 1

MOTION 1: The motion to be considered, forms the first part of an advocacy position statement called the 'COVID-19 Vaccination Pro-Choice Statement'. We request that the Council adopt this position statement and actively advocate to the State Government to remove the vaccination mandate policy.

<p>We request that the Council adopt an advocacy position statement called the 'COVID-19 Vaccination Pro-Choice Statement' with the content:</p> <p>That no person shall or should be:</p> <ul style="list-style-type: none"> a) prevented from performing work or receiving income on the basis of vaccination status; b) discriminated against on the basis of vaccination status; c) coerced or manipulated into the need for vaccination for any reason; d) deprived of any Statutory and Regulatory benefits on the basis of vaccination status; e) restricted access to premises on the basis of vaccination status; f) restricted in any form of community participation on the basis of vaccination status; g) required to provide evidence for any reason of vaccination status; and / or, h) subject to anything under written law that a person who differs in vaccination status is not. <p>CARRIED</p>

4.2 COVID-19 VACCINATION PRO-CHOICE STATEMENT – PART 2

MOTION 2: The motion to be considered, forms the second part of an advocacy position statement called the 'COVID-19 Vaccination Pro-Choice Statement'. We request that the Council adopt this position statement and actively advocate to the State Government to remove the vaccination mandate policy.

<p>We request that the Council adopt an advocacy position statement called the 'COVID-19 Vaccination Pro-Choice Statement' with the content:</p> <p>That the Local Government shall:</p> <ul style="list-style-type: none"> a) not restrict any function, property, or service of the Local Government based on vaccination status; and, b) as far as practicable redeploy or reinstate employees of the Local Government that risk termination or have been terminated on the basis of vaccination status; c) honour all obligations under contract for all persons adversely impacted as a consequence of inferred mandatory requirement for vaccination; and, d) establish means to compensate Local Government employees that have lost income as a consequence of termination on the basis of vaccination status. <p>CARRIED</p>

4.4 COVID-19 VACCINATION PRO-CHOICE STATEMENT – PART 4

MOTION 4: The motion to be considered, forms the fourth part of an advocacy position statement called the 'COVID-19 Vaccination Pro-Choice Statement'. We request that the Council adopt this position statement and actively advocate to the State Government to remove the vaccination mandate policy.

<p>We request that the Council adopt an advocacy position statement called the 'COVID-19 Vaccination Pro-Choice Statement' with the content:</p> <p>That no volunteer, including but not limited to fire & emergency services, service clubs, and community volunteers, shall or should be:</p> <ul style="list-style-type: none"> a) prevented from participating in volunteer roles on the basis of vaccination status; b) limited in their capacity as a volunteer on the basis of vaccination status; c) discriminated against on the basis of vaccination status; d) coerced or manipulated into the need for vaccination for any reason; and/or e) required to provide evidence for any reason of vaccination status. <p>CARRIED</p>

Cr Gibson asked whether there were any other motions relating to the purpose of the meeting. There were no further motions.
