#### 2. REPORTS & PRESENTATIONS

#### 2.1 ALBANY YOUTH SUPPORT ASSOCIATION (AYSA)

Mr Ian Clarke, CEO, and team presented data from the past three (3) years of AYSA servicing Denmark, as part of the contract between the Shire of Denmark and Department of Communities, to provide the Denmark Youth Outreach Program.

Mr Clarke discussed the current contract and case load challenges in meeting demand.

Ms Kath Ward and Ms Amy Palmer, Denmark Senior High School, presented information regarding the mental health of school students, and the resultant impacts on educational and social outcomes. Ms Ward has provided six (6) months of funding to the Youth Outreach Service, delivered by AYSA, to provide an additional two (2) days for the current Youth Officer, taking their employment to full time until December 31, 2022. DSHS is unable to commit further funds to the program beyond this date.

Community Services will meet with the Department of Communities to see if additional funding is available to support the high case loads experienced with the program.
