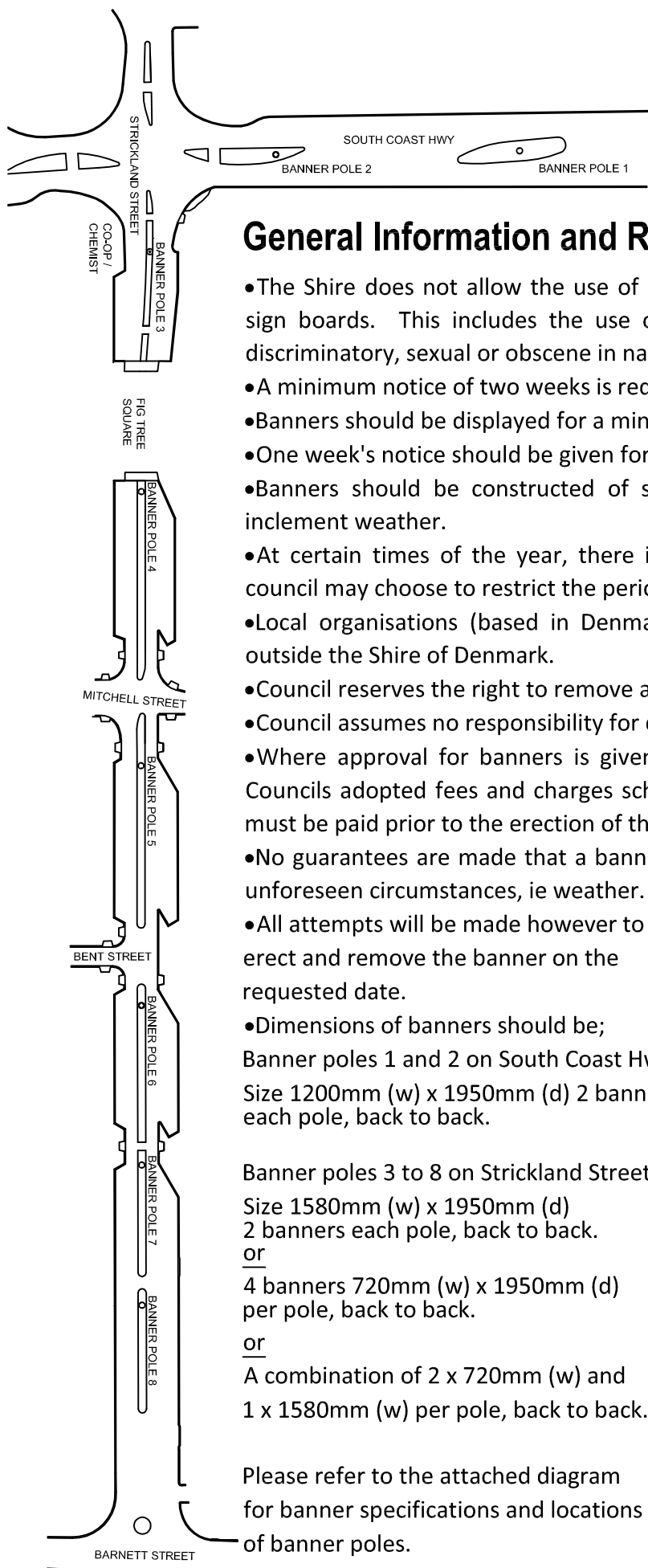

## General Information and Rules of Use

- The Shire does not allow the use of profanity or vulgar language on these public sign boards. This includes the use of language that is libellous, racist, hateful, discriminatory, sexual or obscene in nature.
- A minimum notice of two weeks is required for the erection of banners.
- Banners should be displayed for a minimum of four weeks.
- One week's notice should be given for removal of banners.
- Banners should be constructed of strong, durable materials able to withstand inclement weather.
- At certain times of the year, there is a strong demand for banner displays and council may choose to restrict the period over which they are to be exhibited.
- Local organisations (based in Denmark) will be given priority over those based outside the Shire of Denmark.
- Council reserves the right to remove any signs as considered necessary.
- Council assumes no responsibility for damage to banners.
- Where approval for banners is given, Councils adopted charges relate (refer to Councils adopted fees and charges schedule - as amended from time to time) and must be paid prior to the erection of the banners.
- No guarantees are made that a banner can be erected on a specified date due to unforeseen circumstances, ie weather.
- All attempts will be made however to erect and remove the banner on the requested date.
- Dimensions of banners should be;  
Banner poles 1 and 2 on South Coast Hwy.  
Size 1200mm (w) x 1950mm (d) 2 banners each pole, back to back.
- Banner poles 3 to 8 on Strickland Street  
Size 1580mm (w) x 1950mm (d)  
2 banners each pole, back to back.  
or  
4 banners 720mm (w) x 1950mm (d)  
per pole, back to back.  
or  
A combination of 2 x 720mm (w) and  
1 x 1580mm (w) per pole, back to back.
